# **GENERAL TERMS AND CONDITIONS:**

- i. Conditional offer(s) in tender shall be liable for rejection.
- ii. Acceptance or rejection or deviation of tender terms and conditions shall be finally decided by PCNTDA
- iii. PCNTDA reserves the right to withdraw from sale the materials offered for sale in full or part thereof without assigning any reason whatsoever and also retains the option to cancel a deal even after issue of LOA.
- iv. Quality and Quantity:
  - a. The scrap materials offered purely on "as is where is" basis. Pick and Choose method of collection shall not be allowed.
  - b. The tenderer should thoroughly satisfy themselves about the physical condition of materials at the time of inspection.
  - c. The scrap materials will be sold on lot basis. The entire materials lying in the lot shall have to be lifted by the purchaser so as to clear the entire lot at a time.

# **XX. CHANGE OF QUANTITY:**

- a. During the execution of the Contract, PCNTDA reserves the right to increase or decrease the quantities of items under the Contract but without any change in unit price or other terms & conditions. Such variations shall be applicable for the individual items under the Contract and shall be limited to ±25% of the quantity for which Sale has been invited.
- b. Quantity for which the Sale has been invited may vary at the discretion of PCNTDA In such a case, if it is found the amount deposited by the bidder as sale value is in excess of the actual quantity sold; PCNTDA shall refund such excess amount to the bidder followed by PCNTDA's payment release procedure.

# 1.0 GENERAL INSTRUCTIONS

Visiting hours shall be restricted only within official working days and intending bidders should obtain appropriate permission in advance from the Engineer-in-Charge for the same. No claim on this account will be entertained at any stage. The location of the Kudalwadi Bridge Site is near Tata motor Spine road Junction.

# 2.0 COST OF BIDDING

The Bidder shall bear all the costs and expenses associated with preparation and submission of its Bid including post-bid discussions if any etc. and the PCNTDA shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

# 3.0 THE BIDDING DOCUMENT

# 3.1 CONTENTS OF BIDDING DOCUMENTS

The actionable goods and services required, bidding procedures and contract terms are as prescribed in the Bidding Documents.

# 3.2. UNDERSTANDING OF BIDDING DOCUMENTS

A prospective Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents and fully inform himself as to all the conditions and matters which may in any way affect the scope of work or the cost thereof. Failure to furnish all information required in the Bidding Documents or submission of a Bid not substantially responsive to the Bidding Documents in every respect shall be at the Bidder's risk and may result in the rejection of its Bid.

# 4.0 CLARIFICATIONS ON BIDDING DOCUMENTS

- 4.1. A prospective Bidder finds discrepancies or omissions in the specifications and documents or is in doubt as to the true meaning of any part or requires any clarification on Bidding Documents should make the request / notify the tender inviting authority of PCNTDA in writing. The concerned authority of PCNTDA shall respond in writing to any request for such clarification of the Bidding Documents, which it receives not later than Seven (7) days prior to the deadline for submission of bids stipulated in tender notice. Written copies of the response (Including an explanation of the query but without identifying its source) shall be sent to all prospective bidders who purchased the tender document.
- 4.2. Verbal clarification and information given by the Owner or his employee(s) or his representative (s) shall not in any way be binding on the Owner.

# 5.0 AMENDMENT TO BIDDING DOCUMENTS

- 5.1 At any time prior to the deadline for submission of bids, PCNTDA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Bidding Documents by amendment(s).
- 5.2. The amendment shall be notified in writing or by e-mail or cable to all prospective Bidders, who have received the Bidding Documents at the address contained in the letter of request for issue of Bidding Documents from the Bidders. PCNTDA shall bear no responsibility or liability arising out of non-receipt of the same in time or otherwise.
- 5.3 In order to afford prospective bidders reasonable time to take the amendment into account in preparing their bids, PCNTDA may, at its discretion, extend the deadline for submission of bids.

# 6.0 PREPARATION OF BIDS

# 6.1. LANGUAGE OF BID

The Bid prepared by the Bidders and all correspondence and documents relating thereto, exchanged by the Bidder and PCNTDA, shall be written in English language, provided that any printed literature furnished by the bidder may be written in another language so long as accompanied by an English translation of its pertinent passages. # 7.0 LOCAL CONDITIONS

- 7.1. It shall be imperative on each bidder to fully inform him of all local conditions and factors, which may have any effects on the execution of the contract covered under these documents and specifications. The Owner shall not entertain any request for clarification from bidders, regarding such local conditions.
- 7.2. It must be understood and agreed that such factors have properly been investigated and considered while submitting the proposals. No claim for financial adjustment to the Contract awarded under these specifications and documents shall be entertained by PCNTDA Neither any change in the time schedule of the Contract nor any financial adjustments arising thereof shall be permitted by PCNTDA

# **8.0** DOCUMENTS COMPRISING THE BID

# 1st Part: Bid Guarantee & Pre-Qualification Bid.

- i. Containing Bid earnest money as per the stipulations of the Bid Document and cost of bid documents in separate sealed envelope.
- ii. Containing Documentary evidence in fulfilling the requirements as indicated at SI.No. 4.0 of Section-I of the tender document. The Bidder shall also submit all such other documents deemed necessary in support of their meeting the stipulated qualifying requirement and its credentials.

# 2nd Part: Part-II- Price Bid

Only the successfully pre-qualified bidders shall be considered for opening of price bid.

The commercial bid shall be opened on prior information to all bidders as early as possible. The determination of a Bid's responsiveness will be based on the contents of the Bid itself without recourse to extrinsic evidence. Bids not covering the above entire Scope of Work shall be treated as incomplete and hence rejected.

The Bidder shall quote unit rate in the appropriate schedule of the Bid Form. Bidder shall indicate Bid prices in Indian Rupees only. **Offered price shall be evaluated as per Clause-xiv of "General Terms & Condition" payable on the transactions between the Owner and the Bidder.** As regards the Income Tax surcharge on Income Tax and other corporate taxes, the Bidder shall be responsible for such payment to the concerned authorities Service tax, as applicable on services rendered shall be responsibility of the bidder. # 9.0 BID GUARANTEE

- 9.4 Any bid not secured in accordance with Para 9.1 and 9.3 above shall be rejected by PCNTDA as non-responsive.

# 9.5 The earnest money may be forfeited:

- a. If a Bidder withdraws his bid during the period of bid validity specified by the Bidder on the bid form; or
- b. In case of a successful Bidder fails:
  - i. to sign the contract.
- 9.6 No interest shall be payable by PCNTDA on the above earnest money.

# 10.0 PERIOD OF VALIDITY OF BIDS

- 10.1 Bids shall remain valid for 120(one hundred twenty) days after the date of bid opening prescribed by PCNTDA, unless otherwise specified in the accompanying Special Conditions of Contract. A Bid valid for a shorter period shall be rejected by PCNTDA as non-responsive.
- 10.2 In exceptional circumstances, PCNTDA may solicit the Bidder's consent to an extension of the period of Bid validity. The request and the response thereto shall be made in writing (including cable or fax or email). The Earnest money provided shall also be retained upto the extended period. No interest shall be payable by PCNTDA for retaining the earnest money upto the extended period. A Bidder may refuse the request without forfeiting the earnest money deposited by him. A Bidder granting the request shall not be required or permitted to modify his Bid.

#### SUBMISSION OF BIDS

# 11.0 FORMAT OF BID

- 11.1 The Bid shall be submitted in two parts as described in clause no. 8.0 of Section II.
- 11.2 The Bid shall contain no interline ations, erasures or overwriting except as necessary to correct errors made by the Bidder, in which case such corrections shall be initialed by the person or persons signing the Bid.

# **12.0 SIGNATURE OF BIDS**

- 12.1 The Bid must contain the name, residence and place of business of the person making the Bid and shall be signed and sealed by the Bidder with his usual signature.
- 12.2 Bid by a partnership must be furnished with full names of all partners and be signed with the partnership name, followed by the signature(s) and designation(s) of the authorized partner(s) or other authorized representative(s).
- 12.3 Bids by Corporation / Company must be signed with the legal name of the Corporation/Company by the President, Managing Director or by the Secretary or other person or persons authorized to Bid on behalf of such Corporation / Company in the matter.
- 12.4 A Bid by a person who affixes to his signature the word 'President', 'Managing Director' 'Secretary', 'Agent', or other designation without disclosing his principal shall be rejected.
- 12.5 Satisfactory evidence of authority of the person signing on behalf of the Bidder shall be furnished with the Bid.
- 12.6 The Bidder's name stated on the proposal shall be exact legal name of the firm.
- 12.7 Bids not conforming to all the above requirements may be disqualified.
- 12.8 The original Sale bid document shall be signed by the tenderer / bidder on all pages and will be enclosed with the commercial bid.
- 12.9 The Bidder shall have to give a DECLARATION that he / they have gone through the details of the bidding document.

13.2 The earnest money must be paid throu online for pre-qualification bid.

# 14.0 DEADLINE FOR SUBMISSION OF BIDS

- 14.1 The Bidders have the option of sending the Bid by registered post or submitting the Bid in person. Bids submitted by telex/telegram/fax shall not be accepted. No request from any Bidder to PCNTDA to collect the Bid from airlines, cargo agents etc. shall be entertained.
- 14.2 Bids shall be received by PCNTDA online only, not later than the time & date mentioned in the Invitation to Bid.
- 14.3 PCNTDA may, at its discretion, extend this deadline for the submission of Bids, in which case all rights and obligations of PCNTDA and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended.

# 15.0 LATE BIDS

15.1 Any Bid received by PCNTDA after the time & date fixed or extended for submission of Bids prescribed by PCNTDA, shall be rejected and/or returned unopened to the Bidder.

# 16.0 MODIFICATION AND WITHDRAWAL OF BIDS

- 16.1 Once the intending bidder submits/dropped his/her bid offer, modification/correction/withdrawal of bid(s) shall not be allowed/accepted.
- 16.2 No Bid shall be modified / withdrawn in the interval between the deadline for submission of Bids and the expiration of the period of Bid validity specified by the Bidder on the Bid Form. Withdrawal/modification of a Bid during this interval shall result forfeiture of the earnest money deposited by the bidder.

# **BID OPENING AND EVALUATION**

#### 17.0 OPENING OF BIDS BY PCNTDA

17.1 First the Online Envelope containing Earnest money as per relevant clause of NIT and required documents of qualifying requirement as per clause 4.0 of Section-I shall be opened and only those Bidder whose Bid contains Earnest money and documents of qualifying requirements as per the stipulations of NIT shall be considered eligible for opening of Part-II (Price Bid) of the Bid. In case the above schedule date of opening of Bid is declared holiday by the State / Central Govt. the Bid will be opened on the following working day keeping time unaltered.

17.2 The Bid and its all parts shall be opened in the presence of Bidders' or representative (only one person) duly authorized by the bidder at the date and time scheduled for opening of bids indicated in the NIT or in case any extension has been given thereto. The Bidder / representative shall sign in a register evidencing their attendance .No person / agent shall be allowed to present during opening of Bid without valid authorization from the concerned bidder.

17.3 The Bidders name, bid prices, modifications, bid withdrawals and the presence or absence of the requisite earnest money and such other details as PCNTDA, at its discretion, may consider

appropriate shall be announced at the opening.

17.4 No electronic recording devices shall be permitted during bid opening.

#### **18.0 CLARIFICATION OF BIDS**

18.1 To assist in the examination, evaluation and comparison of Bids, PCNTDA may, at its discretion, ask the Bidder for a clarification of its Bid. The request for clarification and the response shall be in writing and no change in the price or substance of the Bid shall be sought, offered or permitted.

# 19.0 PRELIMINARY EXAMINATION

19.1 PCNTDA shall examine the Bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the Bids are generally in order.

# 19.2 Arithmetical errors shall be rectified on the following basis:

If there is a discrepancy between the unit price and the total price that is obtained by multiplying

the unit price and quantity, the unit price shall prevail and total price shall be corrected. If there is a discrepancy between words and figures, the amount in words shall prevail. If the Bidder does

not accept the correction of the errors as above, his bid shall be rejected and the amount of earnest money shall be forfeited.

The Bidder shall ensure that the price(s) furnished by him are complete. In the case of not quoting

of rates of any item (supply / erection) in the specified price schedules of the Bid Form, PCNTDA

shall be entitled to consider the highest price of the tender for the purpose of evaluation and for the purpose of award of the Contract, use the lowest prices of the tender.

19.3 Prior to the detailed evaluation, PCNTDA shall determine the substantial responsiveness of each Bidw.r.t. Bidding Documents. For purpose of these Clauses, a substantially responsive

Bid is one which conforms to all the terms and conditions of the Bidding Documents without material

deviations. A material deviation is one which affects in any way the prices, quality, quantity or delivery period of the equipment or which limits in any way the responsibilities or liabilities of the

Bidder or any right of PCNTDA as required in these specifications and documents. PCNTDA determination of a Bid's responsiveness shall be based on the contents of the Bid itself without recourse to extrinsic evidence.

19.4 A Bid determined as not substantially responsive shall be rejected by PCNTDA and may not subsequently be made responsive by the Bidder by correction of the non-conformity.

19.5 PCNTDA may waive any minor non-conformity or irregularity in a Bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder.

# 20.0 COMPARISON OF BIDS

20.1 For comparison, individual bid price shall be considered as per Clause of NIT

20.2 Evaluated bid prices of all the bidders shall be compared among themselves to determine the **Highest evaluated Bid** and, as a result of this comparison, the **Highest Bid** may be selected for award of the Contract.

# 21.0 CONTACTING THE OWNER

Bids shall be deemed to be under consideration immediately after they are opened and until such time official intimation of award/rejection is made by PCNTDA to the Bidders. While the bids are under consideration, Bidders and/or their representatives or other interested parties are advised to refrain from contacting by any means, the Owner and/or his employees/representatives on matters relating to the bids under consideration. PCNTDA, if necessary, shall obtain clarifications on the bids by requesting for such information from any or all the Bidders, either in writing or through personal contacts as may be necessary.Bidders shall not be permitted to change the substance of the bids after the bids have been opened.

# **AWARD OF CONTRACT**

#### 22.0 AWARD CRITERIA

22.1 PCNTDA shall award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the **Highest evaluated Bid**, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily. PCNTDA shall be the sole judge in this regard.

22.2 Further, PCNTDA reserves the right to award separate Contracts to two or more parties in line with the terms and conditions specified in the accompanying in the NIT.

# 23.0 OWNER'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

23.1 PCNTDA reserves the right to accept or reject any bid. Without giving any reason

# 24.0 NOTIFICATION OF AWARD

24.1 Prior to the expiration of the period of bid validity and extended validity period, if any, PCNTDA shall notify the successful Bidder in writing by registered letter or by cable or telex or FAX, to be confirmed in writing by registered letter, that his Bid has been accepted.

24.2 The Notification of Award / Letter of Award shall constitute the formation of the Contract.

24.3 The approved bidder on receipt of the LOA has to confirm unconditional acceptance of the same.

#### 25.0 SIGNING OF CONTRACT

25.1 At the same time as PCNTDA notifies the successful Bidder that its bid has been accepted, PCNTDA shall send the Bidder the detailed LOA.

# **26.0 CORRUPT OR FRAUDULENT PRACTICES**

- 26.1 PCNTDA expects the bidders / suppliers / contractors observe the highest of ethics during the process and execution of such contracts. In pursuance of this policy, PCNTDA, Defines for the purpose of this provision, the terms set forth below as follows;
- i) "Corrupt practice" means offering, giving, receiving or soliciting of anything of value to influence the action of a official in the process or in contract execution, and
- (ii) "Fraudulent practice" means a misrepresentation of facts in order to influence a process or the execution of a contract to the detriment of the owner, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the owner from the benefits of free and open competition.

PCNTDA will reject a proposal for award if it determines the bidder recommended for award has

engaged a corrupt or fraudulent practice in competing for the contract in question.

PCNTDA will declare a firm ineligible, either indefinitely or for a stated period of time, if owner any time, determines that the firm has engaged corrupt / fraudulent practices in competing for, or in executing the contract.
